

Green Bay Area Public School District
History of Attendance Area Boundary Changes

- A. Prior to 1955
- All secondary public school students in Green Bay, east of the Fox River, attended Washington Jr. High and East High Schools. East High School also enrolled (on a tuition basis) all of the public high school students from Allouez, Ashwaubenon, Howard, part of Hobart, Preble, and Suamico.
- B. 1955
- Preble High School opened and enrolled all 9th and 10th graders in the new Preble School District, plus a small number of 11th and 12th graders. The boundary on the east side of the attendance area for Washington/East became the Green Bay City limits. By September 1957, no residents of the Preble School District attended Green Bay secondary schools.
- C. 1963
- The Howard-Suamico School District opened Bay Port High School and all 9th and 10th graders from that district attended the new school. Some 11th and 12th graders chose to remain at East High School for graduation.
- D. 1964
- Southwest Junior-Senior High School opened for all 9th and 10th graders and some 11th and 12th grade students from the Town of Ashwaubenon and part of the Town of Hobart. Only the east side of the City of Green Bay and all of the Town of Allouez remained as the attendance area for Washington Jr. and East High Schools.
- E. 1965
- The Town of Preble annexed to Green Bay and the former Preble School District and the Town of Allouez became parts of the Green Bay School District. The boundaries for East High were changed on the east side from the former city limits to the present boundaries: from the East River east along the railroad tracks to Irene St., north on Irene to Main St., west on Main to Deckner Av., and northeast on Deckner to Henry St., northwest on Henry to East Tower Dr. and the Fox River. All public school children in grades 7 and 8 from the Town of Allouez were enrolled at Washington Jr. High.
- F. 1970
- The attendance area boundaries for East and Preble High Schools were changed. Students living south of Broadview Dr. extended to the Fox River in the Town of Allouez would attend Preble. All other students in the Town of Allouez would attend East.
 - Edison Jr. High School opened. The attendance area was the same as Preble High School except in the Town of Allouez. The boundary in Allouez included all junior high school students who lived south of St. Joseph St. extended to the Fox and East Rivers.

- G. 1976
- Edison Jr. High's southern boundary in Allouez was changed from south of St. Joseph St. to south of Mission Rd.
- H. 1977
- Washington Jr. High's southern boundary was moved from Allouez Avenue to Mission Rd. 9th graders living in this area were allowed to finish at Edison. 7th and 8th graders were transferred to Washington Jr. High.
- I. 1979
- Franklin Jr./West and Lombardi Jr./Southwest boundaries changed. The area bounded by Military Av. on the west, Fisk St. on the east, the Bay on the north, and Dousman St on the south was now designated for Franklin Jr./West students. New residents to the area and all 6th graders were required to attend Franklin Jr. High. All 7th and 8th graders could choose which Jr. High to attend but were required to attend West High School. All 9th, 10th, and 11th graders could choose to attend either Southwest or West High Schools.
- J. 1980
- The Broadview boundary in Allouez was adjusted south to the Allouez-DePere line to move all students from Preble to East over a 3-year period.
 - The Norwood attendance area, east of Ashland Av. was attached to the Tank School attendance area.
- K. 1986
- Boundary adjustments involved Beaumont, Jackson, and Tank.
 - High School and Middle School boundaries changed as follows:
 - Jackson Elementary School attendance area was moved from Lombardi/Southwest Schools to Franklin/West Schools.
 - The area bounded by the east side of Ashland Av, the Milwaukee Road Railroad tracks, the Fox River, and both sides of Ninth St. was moved from Franklin/West Schools to Lombardi/Southwest Schools.
 - The area bounded by the East River, the Chicago and Northwestern Railroad tracks, the west side of Main St./Hwy 141, the west side of I-43, and the north side of Hwy. 172 was moved from Edison/Preble Schools to Washington/East Schools.
 - The area bounded by the Fox River, the south side of Hwy. 172, both sides of Bellevue St. to Verlin Rd., the west side of Bellevue St. between Van Rd. and a fence line that runs parallel to and north of Hoffman Rd., the fence line that runs parallel to and north of Hoffman Rd., the East River, and the southern boundary for the Town of Allouez was moved from Washington/East Schools to Lombardi/Southwest Schools.
- L. 1988
- Jefferson School was changed from a district-wide special education school to help alleviate overcrowding at Fort Howard School. Only kindergarten and 1st grade students were placed at Jefferson School.

M. 1990

- Wilder Elementary School opened - new school attendance area:
 - Proceeded from the intersection of Allouez Av. and I-43
 - Northeast on the west side of I-43 to Mason St.
 - West on the south side of Mason St. to Main St.
 - Southeast on the east side of Main St. to the Chicago and Northwestern Railroad tracks
 - West on the south side of the Chicago and Northwestern Railroad tracks to Lime Kiln Rd.
 - South along both sides of Lime Kiln Rd. to Allouez Av.
 - And east on the north side of Allouez Av. to I-43.
- Move a part of Bellevue from Webster to Doty

N. 1991

- McAuliffe Elementary School opened - new school boundaries were:
 - The former Langlade attendance area bounded by Hwy. 172, I-43, Allouez Ave., Hwy. 141/29, and the southern boundary of the school district
 - The former Webster attendance area bounded by Hwy. 141/29, Allouez Av., and I-43.
 - The former Baird attendance area bounded by Greenbrier Rd., I-43, Finger Rd., and the east boundary of the school district.

O. 1992

- Jefferson School expanded enrollment to include grades 2-4 students from the attendance area.
- King Elementary School opened - new school boundaries were:
 - The area west of Packerland, south of West Mason, and east of LaCount was moved from MacArthur attendance area to King.
 - The area west of LaCount, south of West Mason to the District boundary line was moved from the Keller attendance area to King.
 - The area west of Hwy. 41 and north of West Mason was moved from the Keller attendance area to MacArthur.
 - The area bounded by Hazelwood, Packerland, and the Green Bay/Ashwaubenon boundary line was moved from the Kennedy attendance area to MacArthur.
 - The area west of Packerland, south of Hazelwood and the Green Bay/Ashwaubenon boundary line was moved from the Kennedy attendance area to King.

P. 1993

- Washington/East and Edison/Preble boundaries were adjusted.
- An area bounded by Elizabeth St., Baird St., and Main St. changed from the Nicolet attendance area to the Sullivan attendance area.

Q. 1996

- The Fort Howard attendance area was officially divided between Fort Howard School and Jefferson School.
 - Jefferson School's attendance area was established as the area bounded by the Bay of Green Bay, the Fox River, the north side of Bond St., the west side of Ashland Av., the north side of Elmore St., both sides of Norwood Av., and the northerly extension of Norwood Av. to the Bay of Green Bay.
 - **Fort Howard** School's attendance area was redefined as the area bounded by the Fox River, the Chicago and Northwestern Railroad tracks, neither side of Maple St., the northern boundaries of Seymour Park, the Chicago and Northwestern Railroad tracks, both sides of Norwood Av., the south side of Elmore St., the east side of Ashland Av., and the south side of Bond St.
- Transfer the area bounded by Howard St. (neither side), the Fox River, the Chicago and Northwestern Railroad tracks, Maple St. (neither side), the northern boundaries of Seymour Park, and the Chicago and Northwestern Railroad Tracks from the Tank to the **Fort Howard** attendance area.
- The area bounded by both sides of Mather St., both sides of Velp Av., both sides of Atkinson Dr., I-43, and the northerly extension of Norwood Av. was established as an area where parents could choose to enroll their child(ren) at either Jefferson or Elmore Schools on a yearly basis (by February 1 of each school year).
- The boundary between **Tank and Fort Howard** Schools was adjusted due to overcrowded conditions at Tank School.

R. 1999

- "The area bounded by Main St., I-43, Allouez Av., Lime Kiln Rd., and the creek running from Lime Kiln Rd. back to Main St." was moved from the Wilder attendance area to the Langlade attendance area.
- Red Smith School opened resulting in boundary changes involving Baird and Wequiock Elementary Schools and Edison Middle School.
