#### **Question I**

"Shall the Green Bay Area Public School District, Brown County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$16,500,000 for the 2017-2018 school year and for each of the succeeding 9 school years thereafter, for nonrecurring purposes consisting of: maintaining educational programming and class sizes; and retaining staff?"

#### **Question II**

"Shall the Green Bay Area Public School District, Brown County, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$68,250,000 for the public purpose of paying the cost of a district-wide school building and facilities improvement plan consisting of: reconstruction of Baird Elementary School; additions, renovations and improvements to increase capacity, to provide safe and secure entrances and offices at multiple elementary schools, and to improve instructional, support and community service spaces; renovations and improvements for fine arts facilities; and acquisition of related furnishings, fixtures and equipment?"








# OPERATIONAL REFERENDUM: \$16.5M (10-year)

- The District is seeking \$16.5M in additional revenue above its current revenue limit
- The District's revenue limit is 7.5% or a total of \$16.5M per year below the state average
- An operational referendum allows the District to maintain educational programming and class sizes, and retain staff



### Why now?

- Six years of little to no increase in the revenue limit
- Revenue has been outpaced by inflation
- \$21M in expenditures has been cut or deferred in the last two District budgets

## **QUESTION #2**

# FACILITIES REFERENDUM: \$68.25M

#### The facilities referendum addresses:

- Capacity needs at elementary and middle schools; includes building a new Baird Elementary School on the existing site, which increases capacity from 296 to 600 students
- Safe and secured entrances at elementary schools
- Adequate and appropriate spaces for community partners (e.g., Oral Health Partnership, mental health services, etc.), the Fine Arts pathway and the District's project-based charter school John Dewey Academy of Learning

## What happens if the referendum fails?

The District will be required to cut \$18M to balance the 2017-18 budget. The District would need to do the following:

- Reduce educational programs, services and course offerings
- Increase class sizes
- Reduce 150 staff District-wide which will impact all employee groups
