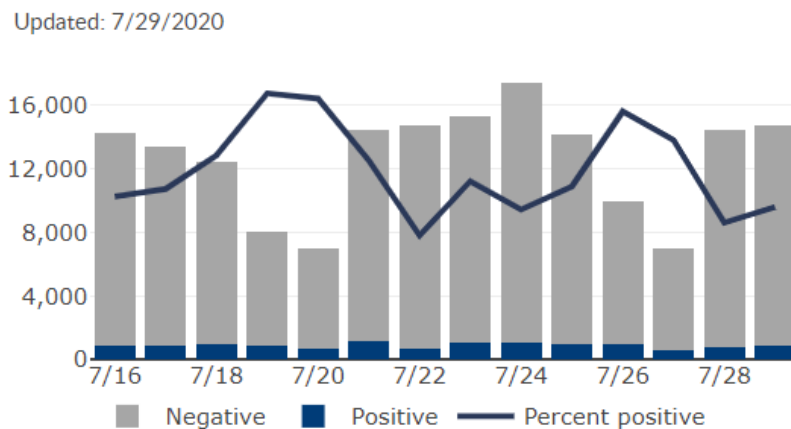

 RE: COVID-19 Update

This weekly memo is designed to keep you up to date on the status of COVID-19 in the state of Wisconsin and Brown County. The District will be monitoring this data provided by the Wisconsin Department of Health Services. The purpose of monitoring those numbers is to determine when it is appropriate to discuss reopening our schools for consideration for on site attendance. Public health professionals and medical experts have provided guidance for reopening metrics. Specifically, they have recommended using the rolling 14-day average for positive tests. When that average is at or below 5% public health professionals and medical experts indicate that it is safe for schools to begin the reopening process.

State-Wide Test Results

- 14-day average, July 27 = 5.9%

Number of people with COVID-19 test results (positive or negative) and the percent positive, by day (last 14 days)

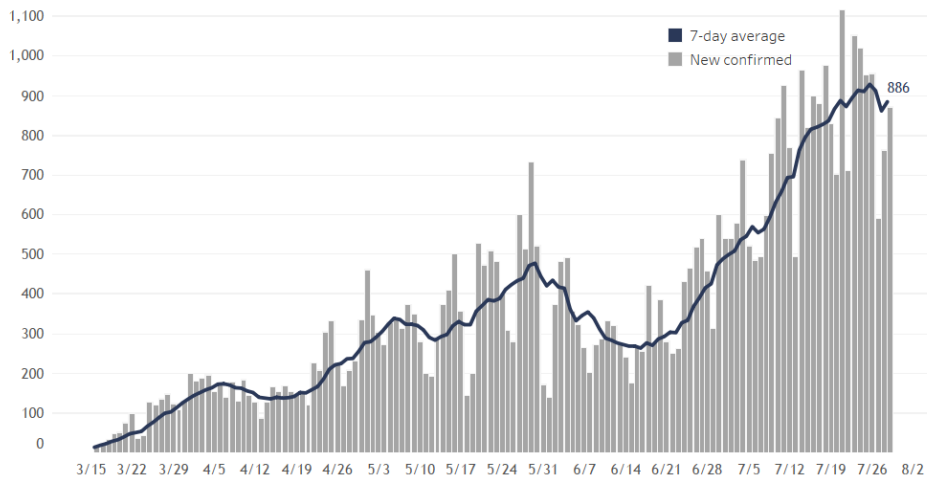

State-Wide Test Results

- Burden in Brown County, July 29 = HIGH
- Burden is the total number of cases per 100,000 Wisconsin residents in the last two weeks.
- Activity level in Brown County, July 29 = HIGH
- Activity level is a summary indicator based on whether the burden (case rate) status is low, moderate, moderately high, or high and whether the trajectory (case change) status is significantly shrinking, growing, or have no statistically significant change

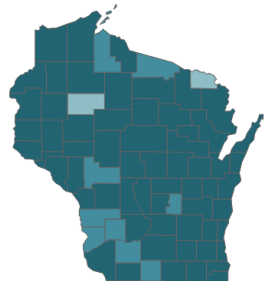

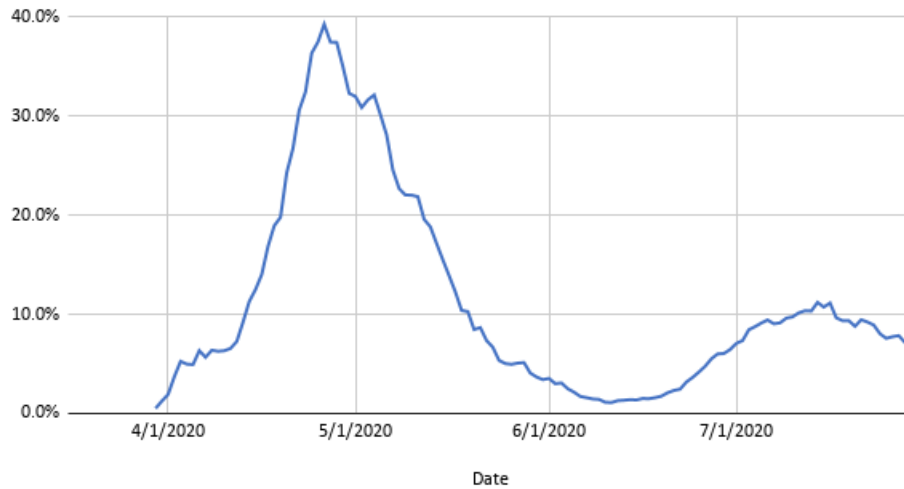

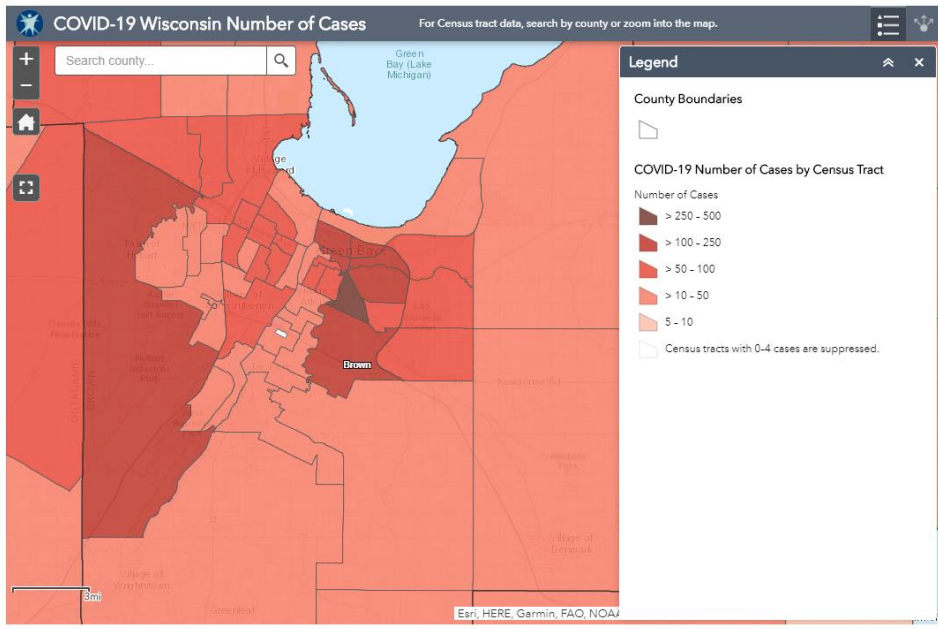
Brown County Average Daily Positive COVID-19 Testing Rates

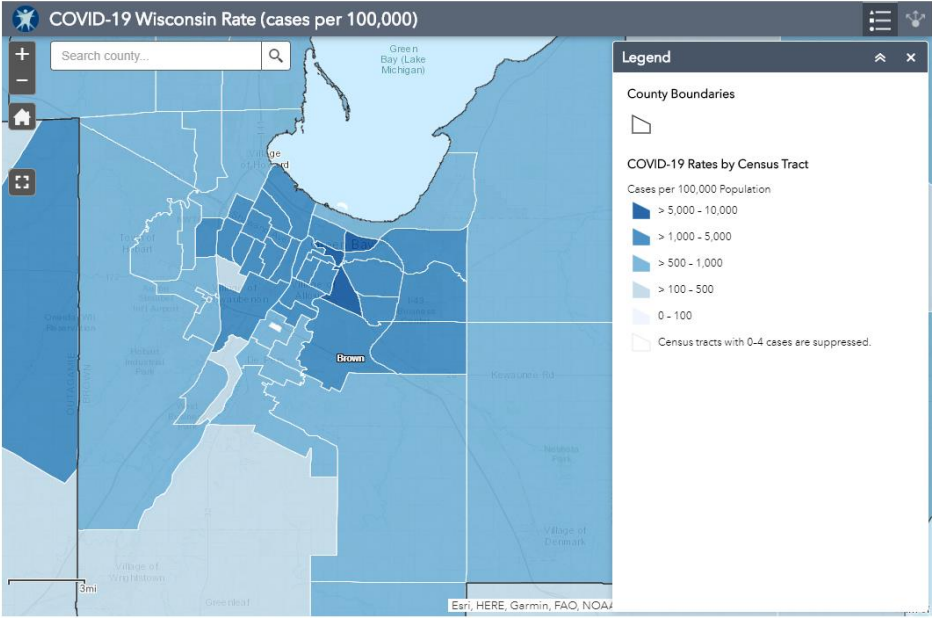
Number of cases by county and census tract data
