The meeting will convene in Open Session in room #331 at 2:00 p.m. with a motion to go into Closed Session at the Green Bay Area Public Schools District Office Building, 200 S. Broadway, Green Bay, WI 54303, Room #337 as the first order of business, pursuant to Wisconsin Statute 19.85 (1)(g) - Conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved, and Wisconsin Statute 19.85 (1)(c) – Considering employment, promotion, compensation or performance evaluation data of any public employee over which the governmental body has jurisdiction or exercises responsibility to wit: discuss strategy for potential litigation and conferring with legal counsel regarding a personnel matter pertaining to the Superintendent of Schools and Learning.

The Board may return to open session to vote on items discussed in closed session in room #331 pursuant to Section 19.85(2), Wisconsin Statute.
